



Amendment #1 to the Sailing Instructions

Composition of the official Committee :

Add :

Chairman of the Race Committee IRC SINGLE-HANDED and DOUBLE-HANDED Pink: Jean-Marc DOUROUX

SI 4. Signals made ashore

Add at 4.1 :

Pink flag for Pink area.

SI 5 Schedule of races

Add at 5.1

A skipper meeting will be organized at 09:30 Saturday April 20th 2019, Sunday 21 April 2019 and Monday 21 April 2019.

SI 7 Races area

Marseille bay and islands around for IRC SOLO and IRC DUO.

The starting zone for IRC SOLO and IRC DUO will be specified every day at the skipper meeting.

SI 9 Marks

Add at 9.1 :

Class	Area	Course mark	Offset mark and Course change	Finishing mark
IRC SINGLE IRC DOUBLE	PINK	TETRAEDRAL ORANGE (*)	TETRAEDRAL YELLOW (*)	TETRAEDRAL GREEN (*)

* except for the long coastal course

SI 11. The start

Replace paragraph 11.4 :

For the single-handed and double-handed classes, the starting line for a coastal course will be moored to go to eventual offset mark or first mark of the course.

SI 13. The finish

Add new paragraph :

13.2 The Race Committee may interrupt a race because of a reason listed in the RRS 32.1, and consider it as completed, taking as finishing order the last rounding order at a mark (this changes RRS 32). For that, she will display flags "S over H", with two sound signals and, if necessary, the class flag of the classes concerned (this modifies race signals) meaning, "The race is interrupted and the last rounding order will constitute the finishing order". The Committee will confirm, if possible, this information by VHF. Anything that may be ground for protest or request for redress happening after the last official rounding order will not be taken in consideration, and no boat can be penalized, except for an action taken under a fundamental RRS or RRS 69 or RRS 14 in case of serious damage or injury.

SI 14 « Penalty system » :

The article 14.4 Jury on the water is deleted and replaced by:

14.4.1 *The first two sentences of rule 44.1 are replaced by: "A boat may take a one-turn penalty in accordance with rule 44.2 when she may have broken one or more rules of Part 2 in an incident while racing (except when she caused serious damage or injury) or rule 31."*

14.4.2 *Rule 64.1(a) is changed so that the provision for exonerating a boat may be applied by the judges without a hearing, and it takes precedence over any conflicting rule of this SI.*

14.4.3 *When a boat*

- (a) Breaks a rule of Part 2 or rule 31 and takes no penalty,*
- (b) Breaks a sailing instruction or class rule governing the bowsprit handling,*
- (c) Breaks rule 49 or a class rule governing the crew position,*
- (d) Gained an advantage after allowing a penalty,*

A judge may penalize her without protest from another boat. The judge will signal a decision with a red flag and a long sound signal. The judge will hail or point toward the boat penalized. A boat penalized by a judge shall take a one-turn penalty in accordance with rule 44.2.

14.4.4 *If a boat penalized by a judge takes no penalty, she shall be disqualified without a hearing.*

14.4.5 *(i) There shall be no request for redress or reopening or an appeal from a decision, action or non-action of a judge.*

(ii) The jury or a boat may protest another boat in case of serious damage or injury or when rule 2 may have been broken, even if a boat has been penalized by a judge in the incident.

14.4.6 *Except when a penalty is signaled by a judge under 14.4.3, part 5 of the Racing Rules of Sailing still applies. Boats, race committee, technical committee and the jury may protest or request redress.*
